Having regard to the Multilateral Agreement between the European Community and its Member States, the Republic of Albania, Bosnia and Herzegovina, the Republic of Bulgaria, the Republic of Croatia, the former Yugoslav Republic of Macedonia, the Republic of Iceland, the Republic of Montenegro, the Kingdom of Norway, Romania, the Republic of Serbia and the United Nations Interim Administration Mission in Kosovo¹ on the establishment of a European Common Aviation Area² ('the ECAA Agreement'), and in particular Article 17(3)a thereof,

Whereas the ECAA Agreement entered into force on 1 December 2017,

HAS DECIDED AS FOLLOWS:

The Annex to this Decision replaces Annex I to the ECAA Agreement, as from 1 September 2019.

Član 3.

Za sprovođenje ovog zakona nadležna su ministarstva nadležna: za poslove saobraćaja, za poslove finansija, za poslove bezbednosti i zdravlja na radu, za poslove zaštite životne sredine, za poslove trgovine i turizma, za poslove pravde, Republički zavod za statistiku, Centar za istraživanje nesreća u saobraćaju i Direktorat civilnog vazduhoplovstva Republike Srbije.

Član 4.
